A fishing permit will be assigned and provided to each Person who submits an application for the permit. There will be a **ten dollar (\$10.00)** charge per permit annually. The application along with a check or money order payable to "Tierra Shores HOA" must be submitted to management for each applicant. Management will process the application and notify the Board. The Board will then schedule for residents to meet at the Tierra Shores office for a photo of the person to be taken. The permit will then be printed and provided to the applicant. Fishing permits are valid for up to one **(1)** year from the date issued and are required to be renewed annually by the applicant. Fishing permits will not be issued to any applicant, or Owner who are delinquent in the payment of their Association monthly assessments!

The fishing permit is required to be present with the person(s) fishing in the designated fishing areas. If requested by the courtesy patrol vendor, or any other Association representative, Owner(s) are required to physically show the permit to the authorized representative. You will be in violation if you do not possess the fishing permit and will be subject to the Violation Enforcement Procedure.

Replacement fishing permits may be purchased for **twenty five dollars (\$25.00)**. Once a replacement fishing permit has been issued, the previous fishing permit assigned will be invalid. Applicants will be required to submit an application in addition to a check or money order made payable to "Tierra Shores HOA." All applications and payments must be sent directly to management.

Fishing is only permitted in the areas designated by the Board of Directors. All residents observed fishing outside of the designated areas will be in violation and will be subject to the Violation Enforcement Procedure.

Designated fishing areas are located at the park on the corner of Bay View / Northshore; at the end of Merit Bay by the boat launching area, by the boat docking area along the lake and in the backyards of the individual Owner lots.

Each residence is permitted to have four (4) guests accompany them while fishing. All guests, family members, etc. must be accompanied by a Tierra Shores Owner or tenant that possesses a valid fishing permit. Persons under the age of fourteen (14) must be accompanied by an adult while fishing within the Lake.

The Association has a strict catch and release policy on all Bass and Catfish caught from the Association's lake. There will be a combined five (5) fish limit on all Crappie and Bluegill and/or trout fish. Eating anything from the lake will be at your own risk.

I acknowledge that if the property address is delinquent in the payment of monthly assessments that my Fishing Permit will be suspended until the account has been paid current. Furthermore, I understand that if my Fishing Permit has been suspended, I may not participate in Fishing from the Lake or use the recreational facilities, etc.

LAKE USE AND FISHING SECTION 4 (c) RULES AND REGULATIONS

C. LAKE USE AND FISHING RULES & REGULATIONS

1. A man made lake is located in the center of the Project. The lake is surrounded with a liner, and certain types of activities may damage the lake liner. To ensure the lake is not damaged and that the soil needed to support the liner is not displaced, no Owner may disturb the landscape or hardscape around the lake without prior written approval of the Board. Pathways around the lake are for maintenance purposes only. Residents and their guests' are strictly prohibited from accessing pathways.

2. **Prohibited Recreational Activities:** Members are strictly prohibited from using the Lake for any recreational activity not specifically permitted in this section and in the Rules and Regulations. Prohibited activities include but are not limited to, kayaking, swimming, wading, diving, snorkeling, surfing, water skiing, windsurfing and the use of any water craft vehicles, including but not limited to, motorized and gas-powered water craft vehicles and/or the use of remote control powered watercrafts, toys, floatation devices, inner tubes, and anything of the like.

3. **Permitted Recreational Activities:** Members may fish in designated areas and use pedal boats and/or canoes provided by the Association. Members engaging in a permitted activity on the Lake shall not intentionally swim or jump into the Lake. Members are strictly prohibited from utilizing and anchoring, mooring, buoy, or any similar device in the Lake, unless the use of such device is approved by the Board.

4. Pets are strictly prohibited from swimming or wading in the Lake. Members shall not dump any animal waste into the Lake. No animal shall be carried, transported, left or turned loose on the lake.

5. Owners shall not deposit any liquids, chemicals, debris or any other substance into the lake, remove or alter any monitoring device, or take any other action which may interfere with the Association's maintenance of the lake.

6. Drinking alcohol and use of glassware or consumption of food while on the lake is prohibited.

7. A fishing permit will be assigned and provided to each Person who submits an application for the permit. There will be a **ten dollars (\$10.00)** charge per permit annually. The application along with a check or money order payable to "Tierra Shores HOA must be submitted to management for each applicant. Management will process the application and notify the Board. 12. Commercial or any "for profit" activities are strictly prohibited on the Tierra Shores Lake.

13. Members who are current in their payment of assessment (dues) may use the Association's lake area for fishing. The use of the Association's amenities may be restricted by the Board of Directors for violation of the Association's rules, delinquent assessments or deliberate abuse of the recreational facilities or common areas upon a duly noticed and held violation hearing.

14. The Association has a strict catch and release policy on all Bass and Catfish caught from the Association's lake. There will be a combined five (5) fish limit on all Crappie and Bluegill and/or trout fish. Eating anything from the lake will be at your own risk.

15. Nuisance activities are prohibited in the Association's lake area such as, fish cleaning, loud music, littering, open fires and any other item at the discretion of the Board of Directors.

16. Only the following approved baits are permitted:
Worms, salmon eggs, cheese, stink bait, mackerel, Bonita, anchovies, night crawlers and meal worms. No Live Bait!

17. Each Person and their guests, etc. are required to clean and remove any fishing materials, hardware, debris, etc. from the Common Areas after fishing.

18. Fishing is only allowed from Sun-up to Sun-down and is not allowed at any other time.
